

TERMS OF SERVICE AGREEMENT

DESCRIPTION OF WEBSITE SERVICES OFFERED

The Site is a religious website which has the following description:

Any and all visitors to our site shall be deemed as "users" of the herein contained Services provided for the purpose of this TOS.

Tyree AME Church does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. You, as the end user acknowledge, accept and agree that Tyree AME Church shall not be held liable for any such updates, modifications, revisions, suspensions or discontinuance of any of our Services and/or products.
